PROCLAMATIONS



OVERVIEW

A proclamation is an official endorsement by a government office in advocacy and recognition of a particular cause or event. Such an endorsement can offer excellent publicity for your state/local chapter. This year, we encourage you to submit a proclamation request for the National Classics Week (April 15-21), culminating in a celebration of Rome's founding on April 21, 753 BC. We encourage you to request a proclamation from the official who is most directly applicable to your chapter. For example, a state chapter should request a proclamation from its governor for that state's own classics week (e.g. Virginia Classics Week). A local chapter should request a proclamation from its mayor for a local classics week (e.g. Exeter Classics Week, Ashburn Classics Week, etc.). DO NOT request a proclamation for a National Classics Week.

When submitting a request, please keep in mind that you must identify an individual office and its officeholder from whom you seek a proclamation. Taking Exeter, New Hampshire as an example, one could request a proclamation for an Exeter Classics Week from the Exeter Board of Selectmen's Chair Don Clements, a New Hampshire Classics Week from Governor Chris Sununu, or a New Hampshire Classics Week from Senator Maggie Hassan.

DOCUMENTATION

When submitting a request, you must provide a sample proclamation containing four or more "And, whereas" clauses that outline the significance of the JCL in your local and/or regional community and Classics Week. We encourage you to additionally provide a cover letter for you document that addresses the official and office from whom you are seeking a proclamation, introduces yourself and the JCL chapter you are representing, and describes the nature of your proclamation request.

Note that the "official look" of your proclamation portfolio is a basic, yet critical aspect in acquiring a government-issued proclamation. To a government official who might have to read twenty requests before reading yours, appearance is sometimes just as important as content. Consider using official state JCL stationery or an official school letterhead to professionalize your work. Additionally, although it is important to do everything in your power to convey the uniqueness of your JCL chapter, take care not to oversaturate your proclamation portfolio - the boilerplate documents are a great place to start.

Finally, make sure your state chair(s) and/or local sponsor review your documents prior to submission. If you have any questions, please do not hesitate to email the NJCL First Vice-President at vpl@njcl.org.

SUBMITTING REQUESTS

Submission

- i. Explore your state/municipality's proclamation request submission policy. A good place to start is an official government website or Google. If you are having trouble finding the requisite information. try contacting your chosen official's office by phone or email and inquiring about proper submission procedures. A good website for such contact information is www.statelocalgov.net.
- ii. Your state/municipal government might allow you to submit your request entirely online. In this case, you need only submit your sample proclamation and not the introductory letter. Make sure to take note of whatever your office requires before proceeding on with your proclamation packet.
- iii. Know the exact name and address of the office to which you will be submitting the request.
- iv. Pay attention to deadlines. Make sure to submit your requests as soon as humanly possible. It is imperative that you allot several weeks of time to ensure that you can secure the proclamation in time.

After Submission

- i. Unfortunately, the only thing you can do after submission is to wait. Sometimes offices will email to confirm receipt of the request but more often you will be left in the dark.
- ii. In the meantime, take the opportunity to prepare for other parts of National Classics Week - look into other methods of recognition or submit a proclamation request to another office! The more recognition you can get for Classics Week, the better.
- iii. If you do end up receiving the proclamation, take the time to celebrate. Having your efforts recognized by the government and disseminated to its citizens is no small feat!

I hope this letter finds you well. My name is Michael Kearney, and I serve as First Vice-President of the National Junior Classical League. I write with a request, which I would like to state directly and then put into context. So first the request: to officially recognize April 17th-23rd, 2016 as Wisconsin Classics Week.

Now the promised context, as to which I shall try to be efficient enough but not at the risk of being uninformative. Since 1936, the National Junior Classical League (NJCL) has worked to promote the study and appreciation of Greco-Roman language, literature, philosophy, and culture among secondary school students. Boasting membership of nearly 50,000 students, NJCL continuously seeks to supplement classroom activities through educational ventures, publicity activities, and community service. Nearly every state in the union contains a "chapter" - not least Wisconsin.

The Wisconsin Junior Classical League (WJCL) contains twelve schools and numbers on thousand members strong. Many attend the annual state Convention in Madison each January and the National Convention each July - week-long festival of Latin held at varying universities across the country. Delegates are untied by the love of the Classics and dedicated to the improvement of their communities through acquaintance with classic civilizations. The WJCL sponsors a number of service events throughout the year - from teaching mythology to younger students to volunteering at food banks.

A particular focus of the National Junior Classical League - and, by extension, the Wisconsin Junior Classical League - is National Classics Week. Centered on April 21st, the traditional date of Rome's founding, the celebratory event offers the opportunity to promote and connect with the legacies of Greece and Rome through service, publicity, and outreach opportunities. This year's theme is Ancient Cities - each day of the week "journeys" through a different ancient city that leads up to Rome's birthday on the 21st.

It is my sincere hope and the earnest desire of the Wisconsin Junior Classical League that you issue a proclamation officially recognizing the interests that citizens of Wisconsin hold in the Classics - officially designating April 17th-23rd as Wisconsin Classics Week. 
